**ORDINANCE 2026-03**, AMENDING CHAPTERS 16.36.090 (MONUMENT SIGNS), 17.60.020 (DEVELOPMENT AND DESIGN STANDARDS IN THE C-N ZONE), AND 17.72.080 (P-C ZONE PLAN) OF THE SOUTH JORDAN MUNICIPAL CODE TO CLARIFY DEVELOPMENT STANDARDS. **APPROVED ON 02-03-2026 BY 5-0 VOTE.**

**RESOLUTION R2026-01**, PROCLAIMING JANUARY 16, 2026 AS RELIGIOUS FREEDOM DAY IN THE CITY OF SOUTH JORDAN. **APPROVED ON 01-06-2026 BY 4-0 VOTE. COUNCIL MEMBER ZANDER ABSENT.**
