GENERAL PURPOSE

Perform apprentice level electrician duties to assure proper operations of all City facilities with little supervision.

SUPERVISOR

ESSENTIAL JOB FUNCTIONS

Meet performance standards established with the employee's manager.

Job attendance is required, except for authorized leave. This position has been determined to be not eligible for remote work because all or a majority of the essential job duties must be performed onsite.

Complete work orders as assigned, relating to building maintenance, city street lights, water pumps, sprinkler transformers and cross walks, provide safe and reliable services.

Operate equipment as needed including backhoe, underground boring equipment, boom truck, trencher to perform necessary repair and system maintenance.

Assist in ordering parts, keep inventory of electrical supplies, as well as understand blue stake's symbols and colors to provide timely repairs.

Assist in troubleshooting various types of electrical equipment including high and low voltage power supplies, motors, pumps, lighting, feeds and telemetry, and make appropriate repairs.

Set forms and pours concrete for streetlight bases. Ability to make appropriate repairs to streetlights.

Plan set and inspect street lighting for appropriate bond release.

Compensated on-call rotations as assigned. Must remain available for phone contact and respond to work site within one (1) hour of notification and be in compliance with the City's Drug & Alcohol policies.

Subject to uncompensated stand-by rotation for a given event, such as a pending snow storm event or response to a natural disaster. Must remain in compliance with the City's Drug & Alcohol policies.

Employee shall live no more than 30 miles from the South Jordan City border and have the ability to travel from their place of residence to the South Jordan City Public Works building in no more than 45 minutes time.

Perform other duties as assigned.

MINIMUM QUALIFICATIONS

1. Education and Experience:

A. Graduation from High School or G.E.D.;

One (1) year snow plowing experience preferred

3. Knowledge, Skills, and Abilities:

Knowledge of blue stake symbols and colors. Ability to apply appropriate blue stake markings for City street light electrical lines and conduit.

Ability to operate a personal computer and Microsoft products.

Ability to operate tools and equipment used in electrical work; ability to follow oral and written instructions; ability to perform heavy lifting and other duties requiring moderate physical strength. Ability to maintain productive working relationship with other employees and supervisor(s).

4. Working Conditions:

Moderately heavy physical activity. May be required to push, pull, or lift medium to heavy weights (40-60 lbs.). May have to stand, walk or sit uncomfortably for extended periods. Daily exposure to weather extremes and seasonal conditions including heat, cold, fumes, noise, dust, or grease. Work at elevated heights. May be exposed to voltage over 440 volts.
